Gretchen Driskell was the only State House Member to skip road funding votes in Lansing; instead, she was campaigning for Congress in Washington DC.

Gretchen Driskell serves as a State Representative, but twice so far she has skipped votes in Lansing to campaign for Congress in Washington DC.

Gretchen Driskell has not passed a single bill during her four years in the Michigan House of Representatives.

salesperson, but not a broker, which involves more responsibility and training) and falsely claimed to be a CPA in Michigan (she has lived in Michigan nearly 30 years and never possessed a CPA license).
